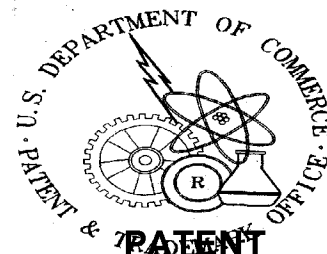

TO WHOM IT MAY CONCERN

Melbourne Health was created and incorporated as a Metropolitan Health Service pursuant to the Health Services (Governance) Act 2000 and an associated Order by the Governor in Council dated 28 June, 2000.

Melbourne Health is the legal successor in title to North Western Health Care Network, but the name of Melbourne Health was decided upon only immediately prior to the Order in Council. Until then, the proposed name was The Royal Melbourne Hospital Health Service, and much of the official paperwork completed by the Government was done in advance of the Order by the Governor in Council.

Accordingly, Melbourne Health has been incorrectly listed for some time (and although correcting applications have been made, continues to be incorrectly listed) on several Government databases as The Royal Melbourne Health Service.

The ABN for Melbourne Health, and its Deductable Gift Recipient number, are one in the same, and is as appears above.
