
ASSIGNMENT OF INVENTION



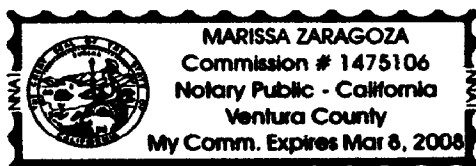
