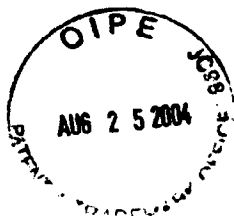

# ASSIGNMENT

WHEREAS, Francesc ROS, Marc JANSA and Macia SOLE are inventors of an invention subject to United States Patent Application Serial No. 10/830,135 filed April, 23<sup>rd</sup> 2004 and entitled "HARDCOPY SERVICING APPARATUS"


