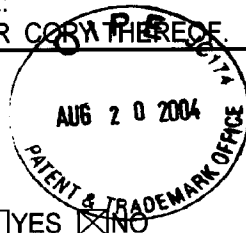

THE FOLLOWING HAS BEEN STATED AND AGREED UPON

1. THE ASSIGNOR is the sole owner of the patents details of which are set out in the attached Schedule.

It will more particularly be in a position to use them, to grant third parties a license, to freely sell its rights, and pursue possible infringers even for facts prior to the present assignment.

4. The present assignment is granted and accepted by both parties for the lump sum of 10 €.






