**CONFIRMATORY RELEASE OF OWNERSHIP
INTEREST TO PATENT RIGHTS**

GLOBAL (GMPC) HOLDINGS INC. ("GLOBAL"), a Canadian corporation having a business address at Suite 3000, 2300 Yonge Street, Toronto, Ontario M4P 1E4, CANADA, hereby confirms that as of September 10, 2004, to the extent it acquired any ownership interest, it has released its Ownership Interest in the U.S. patent applications and patent, and any invention(s) embodied therein (collectively, the "Patent Rights") owned by CARTER GROUP, INC., a Florida corporation having a place of business at 5108 Fairway Oaks Drive, Windermere, Florida 34786, and/or CARTER GROUP CANADA, INC., a Canadian company having a place of business at 2125 Wyecroft Road, Oakville, Ontario L6L 5L7, CANADA. The Patent Rights are listed in Appendix A.

GLOBAL previously caused its provisional rights under the Patent Security Agreement to be recorded with the U.S. Patent & Trademark Office on September 10, 2004 at Reel/Frame 015108/0054. The Patent Security Agreement was, and is, null and void *ab initio* under Section 2.2.1 thereof, because no Secured Bridge Loan was ever executed and no Loan(s) was ever disbursed to Grantor(s) CARTER GROUP, INC. or CARTER GROUP CANADA, INC to secure the provisional rights.

The release of Ownership Interest includes the entire right, title and interest in, to and under the inventions embodied in the Patent Rights, and the U.S. Patent Rights and all divisions, renewals and continuations thereof, and all Patents of the United States which may be granted thereon and all reissues thereof; right, title and interest in to and under all applications for industrial property protection, including, without limitation, all applications for patents, utility models, and designs which may hereafter be filed for said invention in any country or countries other than the United States, together with the right to file such applications and the right to claim for the same the priority rights derived from said United States application under the Patent Laws of the United States, the International Convention for the Protection of Industrial Property, or any other international agreement or the domestic laws of the country in which any such application is filed, as may be applicable; and all forms of industrial property protection, including, without limitation, patents, utility models, inventors' certificates and designs which may be granted for said invention in any country or countries foreign to the United States and all extensions, renewals and reissues thereof.


Therefore, Global hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States of America and the appropriate officers of all other jurisdictions in which any of the Patent Rights are in force, or in which a patent or an application for patent claiming priority to the Patent Rights is pending, to record this Confirmatory Release to demonstrate the release by Global of the Ownership Interest in the Patent Rights.

Global will, at the expense of Carter Group, Inc., execute and deliver, or cause to be executed and delivered, any other or additional releases, documents, certificates, powers or other writings, and take all additional actions, as may be necessary to record the Release of the Ownership Interest in the Patent Rights, to effectuate and validate this Confirmatory Release, and to record this Confirmatory Release of the Patent Rights with the U.S. Patent and Trademark


Office, and the appropriate agencies and offices of all jurisdictions in which the Patent Rights are or may be registered or in force, or in which applications for registration or patent of one or more of the items in the Patent Rights are pending, under the relevant laws of the United States or any other jurisdictions.
