**ASSIGNMENT**

**NOW, THEREFORE**, in consideration of the sum of Fifty Dollars (\$50.00) to me in hand paid, and other good and valuable consideration, the receipt of which is hereby acknowledged, I, the said Dany Felix Maria Michiels have sold, assigned, transferred and set over, and by these presents do hereby sell, assign, transfer and set over unto the said **MILLIKEN EUROPE N.V.**, its successors, legal representatives and assigns, the entire right, title and interest in, to and under the said improvements, and the said application and all divisions, renewals and continuations thereof, and all Letters Patent of the United States which may be granted thereon and all reissues and extensions thereof, and all applications for Letters Patent which have been or may hereafter be filed for said improvements in any country or countries foreign to the United States and all divisions, renewals and continuations thereof, and all Letters Patent of countries foreign to the United States which may be granted thereon and all reissues and extensions thereof; and I hereby authorize and request the Commissioner of Patents of the United States and any Official of any country or countries foreign to the United States, whose duty it is to issue patents on applications as aforesaid, to issued all Letters Patent for said improvements to the said **MILLIKEN EUROPE N.V.**, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

**AND I HEREBY COVENANT** that I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, any agreement in conflict herewith.

**AND I HEREBY FURTHER COVENANT** that I will communicate to the said Corporation, its successors, legal representatives and assigns, any facts known to me respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the said Corporation, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in all countries.


