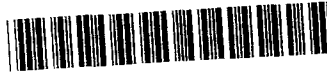

ASSIGNMENT

WHEREAS, Chase Design, Inc., a corporation of the state of New York, having a place of business at 1400 East Genesee Street, Post Office Box 49, Skaneateles, New York 13152 (hereinafter referred to as Assignor), has acquired an interest in an invention pertaining to certain new and useful improvements in EXTENDABLE BATTERY CHARGER, for which an application for United States Letters was signed by us on even date herewith; and

Assignor hereby authorizes and requests the Patent Office Officials in the United States and in any and all foreign countries to issue any and all of said Letters Patent, when granted, to said Assignee as the owner of the entire right, title, and interest in and to the same, for the sole use and behoof of said Assignee, its successors and assigns.

FURTHER, Assignor agrees to communicate to said Assignee, or its representatives any facts known to Assignor respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, continuations-in-part, substitution, renewal and reissue applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to said Assignee, make all rightful oaths and generally do everything possible to aid said Assignee, its successors and assigns, to obtain and enforce proper protection for said invention in the United States and in any and all foreign countries.
