ASSIGNMENT

Further, I agree that I will communicate to said GREAT DANE LIMITED PARTNERSHIP all facts known to me respecting said invention, and testify in any legal proceedings, sign all lawful papers, make all rightful oaths, and generally do everything possible to said GREAT DANE LIMITED PARTNERSHIP, its successors and assigns, to obtain and enforce proper protection for said Letters Patent in the United States and in any and all foreign countries.
