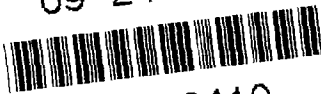


ASSIGNMENT
