where the original content of Art. 9 was in force between 30<sup>th</sup> November 2001 and 30<sup>th</sup> June 2002 in the form of:

## § 9

The Parties agree that the exclusive owner of any patents, inventions and copyrights, which may be related to projects realized by ADB Polska is ADB. ADB Polska is entitled to the right to make use, in scientific works and publications, of information gained during realization of projects commissioned by ADB.

Utilization of such information will require a prior written approval by ADB and cannot be used to gain financial profits by ADB Polska.

from the day of 1<sup>st</sup> July 2002, Art. 9 of the agreement between the Parties, according to an annex No. 1 signed between the Parties, has been changed into the form of:

## § 9

"The Parties agree, in accordance with article 11 of the 30<sup>th</sup> June 2000 Act "Industrial Property Law" /Journal of Law, year 2001, No. 49 pos. 508/, that the ownership of patents, inventions and copyrights that may be related to projects realized by ADB Polska is entitled: to ADB in 95% and to ADB Polska in 5%

ADB Polska is entitled to the right to make use, in scientific works and publications, of information gained during realization of projects commissioned by ADB.

Both Parties have the right and will always discuss with each other all the issues related to:

- preparing application documents to the Patent Office of the Republic of Poland and patent offices of other countries and regional treaties, including the PCT international application
- filing application on a project to the Patent Office of the Republic of Poland and patent offices of other countries and regional treaties in order to receive patent on behalf and in the favor of both Parties,
- taking part in contentious issues regarding the projects before ruling authorities of the Patent Office of the Republic of Poland and courts of law.

All costs related to the above activities are covered by ADB".
