2. Assign and convey to and confirm in Assignee the entire right, title and interest in and to all future improvements in said inventions and discoveries in said Letters Patent of the United States of America.

3. Authorize Assignee to file patent applications in any or all countries on any or all of said inventions and discoveries in my name or in the name of Assignee or otherwise as Assignee may deem advisable, under the International Convention or otherwise;

4. Authorize and request the Commissioner of Patents of the United States of America and the empowered officials of all other governments to issue or transfer all said Letters


Patent to Assignee, as assignee of the entire right, title and interest therein or otherwise as Assignee may direct;


