

WE, KENT ASHBY of 1353 Canyon Road, Logan, UT 84321; S. CURTIS NYE of 2622 West 2375 North, Clinton, UT 84015; DAVID C. WINTER of 1956 East 2050 North, Layton, UT 84040, and ROBERT A. ASTLE of 1068 West Turnberry Circle, Farmington, Utah 84025, have invented a method and apparatus entitled TABLE, hereinafter called the "invention."

Cooperation to the best of my ability in the execution of all lawful documents, the production of evidence, nullification, reissue, extension, or infringement proceedings involving said invention.


