Assignor also hereby agrees to communicate to Assignee, its successors, assigns and representatives, any facts known respecting any improvements, and, at the request and expense of Assignee, to testify in any legal proceedings, sign all lawful papers, execute all divisional, reissue, substitute, reexamination and continuation applications, make all lawful oaths, and generally do everything possible to aid Assignee, its successors, assigns and representatives, to obtain and enforce proper patent protection for said invention in all countries.
