acts, including the execution and acknowledgment of instruments, furnishing of information and giving of testimony, that may be or become necessary for obtaining, sustaining, or reissuing United States and foreign letters patents for said invention, and for maintaining and perfecting the Assignee's right to said invention and letters patent, particularly in cases of interference and litigation.




