WHEREAS WE, Frederick A. Kamke and Harrison Sizemore, III, have invented certain new and useful improvements in an invention entitled: VISCOELASTIC THERMAL COMPRESSION OF WOOD, for which a United States Patent Application bearing Serial Number 10/771,511 having been filed on February 5, 2004,




