FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, Brooktree Corporation, Inc., a California corporation with principal offices at 4311 Jamboree Road, Newport Beach, CA 92660-3095 (the "Grantor"), hereby grants to Conexant Systems, Inc. with principal offices at 4311 Jamboree Road, Newport Beach, CA 92660-3095 (the "Grantee"), a security interest in (i) all of the Grantor's right, title and interest in and to the United States patents and patent applications (the "Patents") set forth on Schedule A attached hereto; (ii) all Proceeds (as such term is defined in the Mindspeed Security Agreement referred to below) of the Patents; and (ii) all causes of action arising prior to or after the date hereof for infringement of any of the Patents.

THIS GRANT is made in connection with the grant of Mindspeed Technologies, Inc. ("Mindspeed") to secure the satisfactory performance and payment of all the Obligations of Mindspeed, as such term is defined in the Security Agreement among Grantor, various subsidiary guarantors and Grantee, dated as of June 27, 2003 (as amended from time to time, the "Mindspeed Security Agreement"). Upon termination of the security interest granted herein in accordance with the terms of the Mindspeed Security Agreement, the Grantee shall, upon such satisfaction, execute, acknowledge, and deliver to the Grantor an instrument in writing releasing the security interest in the Trademarks acquired under this Grant.
