ASSIGNMENT

WHEREAS, we Anthony Gargano, of 5705 South Park Drive, Savage, Minnesota 55378, Keith Gossen, of 9420 Shady Oak Lane, Carver, Minnesota 55315, and Charles W. Extrand, of 408 East Minnehaha Parkway, Minneapolis, Minnesota 55419, have invented certain new and useful improvements in SEALING SYSTEM FOR PORTS OF VESSELS FOR CORROSIVE FLUIDS, for which an application for Letters Patent of the United States has been made, and which may be identified in the United States Patent Office by Application No. 10/466,405, filed December 23, 2003.

I further authorize said Assignee, its successors and assigns, or anyone it may properly designate, to apply for Letters Patent, in its own name if desired, in any and all foreign countries, and additionally to claim the filing date of said United States application and/or otherwise take advantage of the provisions of the International Convention.

Upon said consideration I do hereby covenant and agree with the said Assignee, its successors and assigns, that I will not execute in writing or do any act whatsoever conflicting with these presents, and that I or my executors or administrators will at any time upon request, without further or additional consideration, but at the expense of the said Assignee, its successors and assigns, execute such additional writings and do such additional acts as said Assignee, its successors and assigns, may deem necessary or desirable to perfect the Assignee's enjoyment of this grant, and render all necessary assistance in making application for and obtaining original, divisional, reissued or extended Letters Patent of the United States, or of any and all foreign


countries on said invention, and in enforcing any rights occurring as a result of such applications or patents, by giving testimony in any proceedings or transactions involving such applications or patents.


