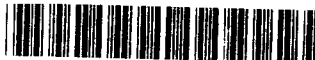

Brush & Co., Inc.**, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

AND WE HEREBY covenant that We have full right to convey the entire interest herein assigned, and that We have not executed, and will not execute, any agreement in conflict herewith.



legal representatives and assigns, to obtain and enforce proper patent protection for said Improvements in all countries.


