**Assignment of Invention**

WHEREAS, WE, **Kirsten Möller** of Auf der Hude 59 D-33175 Bad Lippspringe (GERMANY) ; **Robert Taylor** of Venelle des Platanes 1300 Wavre (BELGIUM) ; **Johannes Beuse** of Hansaallee 10 D-40547 Düsseldorf (GERMANY) respectively, have invented certain new and useful improvements in: **Method and device for cooling a mass of a substance** for which: (a) an application for Letters Patent was filed on herewith, having Application No. \_\_\_\_\_; or (b) for which an application for a United States patent was executed on \_\_\_\_\_, and

Further, we agree that we will communicate to said ASSIGNEE or its representatives any facts known to us respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, substitute, renewal and reissue applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to said ASSIGNEE, make all rightful oaths, and, generally do everything possible to aid said ASSIGNEE, its successors and assigns, to obtain and enforce proper protection for said invention in the United States and its territorial possessions.

The undersigned hereby grant(s) authorized representatives of the above identified ASSIGNEE(S) the power to insert on this assignment any further identification which may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document.
