

ASSIGNMENT OF PATENT APPLICATION

WHEREAS, WE, **Abraham Phillip Lee**, a citizen of the United States, residing at 11 Murasaki Street, Irvine, California 92612; and **Yung-Chieh Tan**, a citizen of Taiwan, residing at 1107 Palo Verde, Irvine, California 92612 (hereinafter referred to as "ASSIGNORS"), have invented a certain invention entitled **MICROFLUIDIC DEVICES FOR CONTROLLED VISCOUS SHEARING AND FORMATION OF AMPHIPHILIC VESICLES**, for which an application for Letters Patent of the United States of America has been filed on February 11, 2004, and assigned U.S. Patent Application Serial No. 10/777470; and

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, ASSIGNORS hereby sell, assign, transfer and set over unto the said ASSIGNEE, its successors and assigns, the full and exclusive right, title and interest to said invention and to all Letters Patent or application or similar legal protection, not only in the United States and its territorial possessions, but in all countries foreign thereto to be obtained for said invention by said application, and to any continuation, division, renewal, substitute or reissue thereof or any legal equivalent thereof in the United States or a foreign country for the full term or terms for which the same may be granted, including all priority rights under the International Convention; and ASSIGNORS hereby authorize and request the United States Commissioner of Patents and Trademarks and any officials of foreign countries whose duty it is to issue patents or any legal equivalent thereof to said ASSIGNEE, its successors and assigns, in accordance with this Assignment.


ASSIGNORS hereby covenant that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Agreement;

ASSIGNORS further covenant that ASSIGNEE will, upon its request, be provided promptly with all pertinent facts and documents relating to said application, said invention and said Letters Patent and legal equivalents as may be known and accessible to ASSIGNORS and will testify as to the same in any interference or litigation related thereto and will promptly execute and deliver to ASSIGNEE or its legal representative any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue and enforce said application, said invention and said Letters Patent and said equivalents in the United States or in any foreign country, which may be necessary or desirable to carry out the purposes thereof.
