

ASSIGNMENT

I, one of the persons named below, hereby state and agree as follows:

I have invented certain new and useful improvements disclosed in an application for United States Letters Patent entitled FEEDBACK CONTROL LOOP FOR AMPLITUDE MODULATION IN A POLAR TRANSMITTER WITH A TRANSLATIONAL LOOP, executed by me on even date herewith, and in U.S. Provisional Application No. 60/612,734, filed September 24, 2004, (collectively the "application").

AND I HEREBY covenant that I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, any agreement in conflict herewith;

AND I HEREBY further covenant and agree that I will communicate to ASSIGNEE any facts known to me respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, substitute and reissue applications, make all rightful oaths and generally do everything possible to aid ASSIGNEE to obtain and enforce proper patent protection for said improvements in all countries.
