Nothing contained in this Bill of Sale and Assignment is intended to provide any rights to the Purchaser or the Seller beyond those rights expressly provided to the Purchaser or the Seller in the Purchase Agreement. Nothing contained in this Bill of Sale and Assignment is intended to impose any obligations or liabilities on the Purchaser or the Seller beyond those obligations and liabilities expressly imposed on the Purchaser or the Seller in the Purchase Agreement. Nothing contained in this Bill of Sale and Assignment is intended to limit any of the rights or remedies available to the Purchaser or the Seller under the Purchase Agreement.

This Bill of Sale and Assignment shall be construed in accordance with, and governed in all respects by, the internal laws of the State of California (without giving effect to principles of conflicts of laws).
