4. The Assignor agrees, at the request and expense of the Assignee, to execute any further documents and do all things which may be necessary to give effect to this assignment including enabling the Assignee to fulfil all relevant national registry requirements for the recordal of the assignment of the Patents.
5. The Assignee acknowledges that the Assignor does not, in this assignment, give any representation or warranty in respect of the Patents including, without limitation, that any applications will proceed to grant.
6. The Assignor agrees to give the Assignee, at the Assignee's expense, such assistance as the Assignee may reasonably require to enable or assist the Assignee to bring any action for infringement of the Patents or to defend any attack against their validity.
7. This assignment includes the right (where applicable) to file applications under the Paris Convention, corresponding to or based on any of the applications for Patents and to claim priority from those applications.

8. This assignment may be entered into in any number of counterparts. This has the same effect as if the signatures on the counterparts were on a single copy of this assignment.
9. This assignment is governed by and shall be construed in accordance with English law and the parties submit to the jurisdiction of the English courts for all purposes relating to this assignment.




