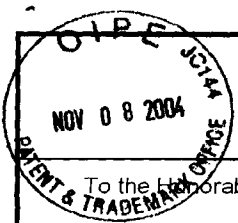
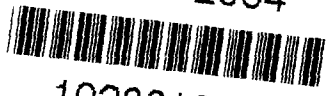

**インクジェット式記録装置およびインクジェット式記録方法**
