ASSIGNMENT

WHEREAS, WE, Chester L. Struble and Lambert Muhlenberg, are the inventors of ATRIOVENTRICULAR DELAY ADJUSTMENT for which an application for a United States Patent was filed on April 22, 2002, under Serial No. 10/127,038; and

I hereby request the Honorable Commissioner of Patents and Trademarks to issue the Letters Patent to Corporation in accordance with this instrument.

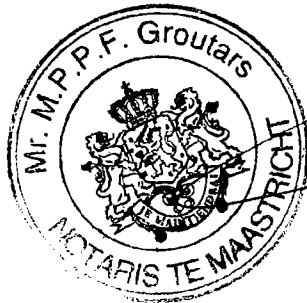




