Agreement between you and Cobra Therapeutics Limited ("the Company") dated 11<sup>th</sup> June 2001 ("the Agreement")


It was announced on 29 April that the Company is involved in restructuring which will involve its R & D business being separated from its contract manufacturing business. The R & D activities, along with the staff involved in that business, will be transferred to ML Laboratories PLC ("ML"), the Company's parent company, following which ML will sell the Company (which will at that stage retain only its contract manufacturing business) to Buyers Guide PLC and ML. Both businesses will continue to work together in the future and indeed for the foreseeable future the Company will remain a subsidiary of ML. However, since the Agreement, and the rights subject to it, are more closely associated with the R&D Business ML and Cobra have agreed that the Agreement and the rights granted under it should be transferred to ML.
