

ASSIGNMENT

WHEREAS, I, Jean-Hugues Soulier of Vaucresson, France, have made certain inventions which are described in an application for Letters Patent of the United States entitled TUB FOR BATHING (a/k/a Ove 1700 Bathtub) filed on January 7, 2005 as U.S. Serial No. 29/220,909 preparatory to obtaining United States Patent therefor; and

WHEREAS, Kohler France SAS (hereinafter referred to as Company), a French Societe Anonyme having a place of business at Paris, France, is desirous of acquiring the entire interest in said inventions worldwide (herein "worldwide" includes throughout the United States of America and its territories, throughout all other countries and under all international agreements);

I hereby sell, assign and transfer unto said Company and its successors and assigns the entire right, title and interest worldwide in and to said inventions, the aforesaid application, all other applications hereafter filed based in whole or in part on said inventions and all Letters Patent granted upon said applications, and I do hereby authorize and request the Commissioner of Patents and Trademarks to issue said Letters Patent to said Company. I further grant to said Company and its successors and assigns the right to claim for any of said applications the full benefits and priority rights of any international agreement between the United States and any foreign country or countries or between any other countries. This transfer shall also include any European Community design rights.

I hereby warrant that I have the full right to make the conveyance herein, and I hereby covenant that I and my heirs, legal representatives and assigns will communicate to said Company and its representatives, successors and assigns all facts known respecting said inventions, execute all divisional, continuing, reissue, reexamination and foreign or international applications, together with individual assignments therefor, make all rightful oaths, sign all lawful papers, testify in any legal proceeding and generally do everything possible to aid said Company and its successors and assigns in the obtaining of Letters Patent.



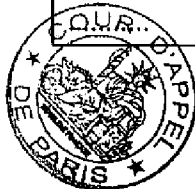
