ARTICLES OF AMENDMENT  
TO THE ARTICLES OF INCORPORATION OF  
CSO AKER MARINE CONTRACTORS, INC.

Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, CSO Aker Marine Contractors, Inc. (the "Corporation") hereby adopts the following Articles of Amendment to its Articles of Incorporation to change the name of the Corporation to "Technip Offshore Moorings, Inc."

ARTICLE I

The name of the corporation is CSO Aker Marine Contractors, Inc.

ARTICLE II

The following amendment to the Articles of Incorporation was adopted by the Shareholders of the Corporation as of November 12, 2002.

ARTICLE ONE of the Articles of Incorporation is hereby amended to read as follows:

ARTICLE III


