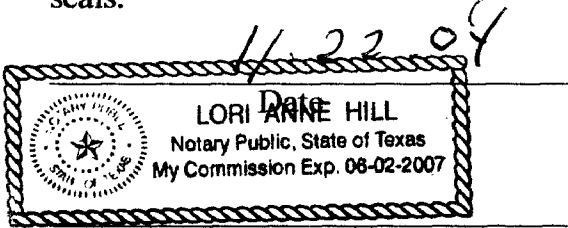

AND we hereby covenant and agree that we will at any time upon the request and at the expense of said assignee execute and deliver any and all papers and do




