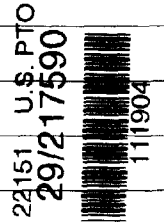

ASSIGNMENT




