## RELEASE OF SECURITY INTEREST IN PATENTS

This **RELEASE**, dated as of January 31, 2005, is made by **CREDIT SUISSE FIRST BOSTON**, as Collateral Agent, pursuant to the termination of the Grant of Patent Security Interest ("Security Interest") dated March 16, 2004.

**WHEREAS**, pursuant to the Security Interest dated March 16, 2004, and recorded with the United States Patent and Trademark Office on April 6, 2004 at Reel/Frame No. 015177/0391 and on April 6, 2004, at Reel/Frame No. 015177/0354, **TRANSPORTATION TECHNOLOGIES INDUSTRIES, INC.**, a Delaware corporation ("TTI" or "the Company"), and certain direct and indirect subsidiaries of the Company, including **BOSTROM SEATING, INC.** and **GUNITE CORP.** (collectively referred to herein as the "**Grantors**"); granted **Credit Suisse First Boston** a security interest in their patents and all applications and registrations therefore, technology and know-how, and all licenses, royalties and other monies relating thereto;

**WHEREAS**, **Credit Suisse First Boston** acknowledges full payment, complete performance and satisfaction of all the obligations as defined in the Security Interest have been made;

**WHEREAS**, the **Grantors** have requested that **Credit Suisse First Boston** release its security interest in the patents and all applications and registrations therefore, technology and know-how, and all licenses, royalties and other monies relating thereto, in connection with the termination of the Security Interest (the "Released Collateral").

**NOW, THEREFORE**, **Credit Suisse First Boston**, as the Collateral Agent, having been duly authorized to do so on behalf of itself, hereby **RELEASES** all of its security interest granted to the Collateral Agent under the Security Interest, in the patents, including but not limited to each of the patents set forth in Schedule A, attached hereto and incorporated herein by reference, together with the goodwill of the business symbolized by said patents, and the registrations of and applications for said patents, technology and know-how, and all licenses, royalties and other monies relating thereto.

**Credit Suisse First Boston** agrees to provide the **Grantors** with any information and additional authorization necessary to effect the release of **Credit Suisse First Boston's** security interest in the Released Collateral.
