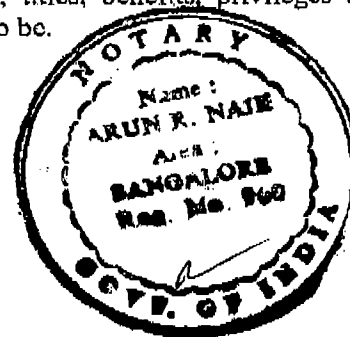
ASSIGNMENT

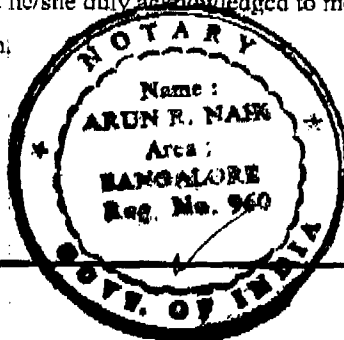
