AND, for the consideration aforesaid, Jean-Marc GUILLEZ, Paul QUEVEAU and Gérard QUEVEAU do hereby agree that their executors and legal representatives will make, execute and deliver any and all other instruments in writing including any other documents, and will communicate to said SOCIETE EUROPEENNE DE BREVETS AUTOMOBILES, its successors and representatives all facts known to them relating to said improvements and the history thereof and will testify in all legal proceedings and generally do all things which may be necessary or desirable to more effectually secure to and vest in SOCIETE EUROPEENNE DE BREVETS AUTOMOBILES, its successors or assigns the entire right, title and interest in and to the said improvements, inventions, applications, Letters Patent, rights, titles, benefits, privileges and advantages hereby sold, assigned and conveyed, or intended so to be.
