In addition, ASSIGNOR has sold, assigned and set over and hereby does sell, assign and set over, unto ASSIGNEE, its successors and assigns, the right to claim priority in any and all foreign applications, including applications filed under the Patent Cooperation Treaty, to the above-referenced applications and any and all provisional, continuation, divisional, and continuation-in-part applications for the inventions.
