ASSIGNMENT OF INVENTION

WHEREAS, we, Larry Appalucci, Dave McGoldrick, Paul A. Roberts and George West, residing at 503 Ridgeview Lane, Villanova, Pennsylvania 19085, 939 Thorne Drive, West Chester, Pennsylvania 19382, 540 Collins Avenue, Collingswood, New Jersey 08107 and 64 Fredrick Blvd., Swedesboro, New Jersey 08085, respectively and jointly have made a certain new and useful invention in the METHOD AND SYSTEM FOR TRACKING CONTAINERS HAVING METALLIC PORTIONS, COVERS FOR CONTAINERS HAVING METALLIC PORTIONS, TAGS FOR USE WITH CONTAINER HAVING METALLIC PORTIONS AND METHODS OF CALIBRATING SUCH TAGS, and are about to apply for Letters Patent of the United States based thereon;

title and interest in and throughout the United States, its territories and all countries foreign thereto in and to said invention and any improvements thereon which may be made, conceived or acquired by us during the course of our association with the said CHECKPOINT SYSTEMS, INC., and for one year thereafter, in and to said application for Letters Patent and any and all Letters Patent and extensions thereof of the United States and countries foreign thereto which have been or may be granted on said invention or any part thereof, or any improvements thereon or on said application, or any divisional, continuing, renewal, reissue, or other application and all international priority rights associated therewith, based in whole or in part thereon, or based upon said invention, or any improvements thereon;

TO BE HELD AND ENJOYED by the said CHECKPOINT SYSTEMS, INC. and its legal representatives and assigns to the full ends of the terms for which said Letters Patent, or any of them, have been granted or may be granted as fully and entirely as the same would have been held and enjoyed by us had no sale and assignment of said interest been made; and we do hereby authorize and request the Commissioner for Patents to issue any and all Letters Patent which may be granted upon the said invention above referred to, or any of them, or upon said invention or any part thereof, or upon any improvements thereon which may be made, conceived or acquired by us during the course of our association with the said company and for one year thereafter, to said CHECKPOINT SYSTEMS, INC., and we hereby agree for ourselves, our heirs, executors and administrators, to execute without further consideration, any further legal documents and any further assignments and any releases, reissues, renewals or other applications for Letters Patent that may be deemed necessary by CHECKPOINT SYSTEMS, INC., fully to secure to the CHECKPOINT SYSTEMS, INC. its interest as aforesaid in and to said invention or any part thereof or any improvements thereon, and

in and to said several Letters Patent, or any of them.

We do hereby covenant for ourselves, and our legal representatives, and agree with CHECKPOINT SYSTEMS, INC., and its legal representatives, that we have granted no license to make or sell the said invention, that prior to the execution of this deed our right, title and interest in the said invention have not been encumbered, that we then had good right and title in and to the invention and that we have not executed and will not execute any instrument in conflict therewith.



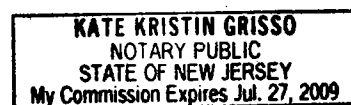


