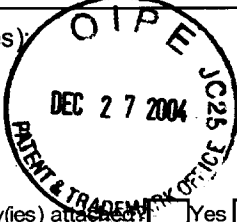



THE said ALEXANDER HARLEY, hereby further agrees, undertakes and covenants that he will sign or execute such further documents, assurances, applications, instruments or any other writing that may be requested by ALLSEATING CORPORATION or its legal representatives for the purpose of obtaining or issuing any Letters Patent for the said inventions or any re-issue or extensions thereof, or any improvements therein in order that all of his right, title and interest in the same may be vested in ALLSEATING CORPORATION, its successors and assigns.
