This ASSIGNMENT OF PATENT is made this 7th day of June, 2005 by Andrew Richardson, Esq., Trustee in Bankruptcy ("Trustee") for Quantum Pure Aire Corporation, a Rhode Island Corporation (originally named Quantum Electronics Corporation) ("Quantum") currently in Chapter 7 bankruptcy to Quantum Zone, LLC a Rhode Island limited liability company having a primary business address of 333 Strawberry Field Road, Warwick, Rhode Island 02886 ("LLC").

WITNESSETH:

WHEREAS, Quantum did obtain by assignment from William H. and Edward F. Racca and/or MV Research Company, LLC a United States Patent for an ozone generator plate, No. 6,024,930, dated February 15, 2000 (the "Patent");

WHEREAS, Quantum is currently in Chapter 7 bankruptcy;

WHEREAS, Trustee is trustee in bankruptcy for Quantum as appointed by the Federal Bankruptcy Court for the District of Rhode Island; and

WHEREAS, LLC is desirous of acquiring the entire right, title and interest in said Patent; and

WHEREAS, on March 26, 2005, the United States Bankruptcy Court entered a Judgment approving the Notice of Sale;

AGREEMENT:

NOW, THEREFORE, in consideration of certain cash payment more particularly described in that certain Bill of Sale made by Trustee to LLC of even date herewith, and other good and valuable consideration, the sufficiency of which is hereby acknowledged, Trustee hereby does sell, assign and transfer unto LLC the entire right, title and interest in and to the Patent aforesaid; the same to be held and enjoyed by LLC for its own use and behoof, and for its legal representatives and assigns, to the full end of the term for which said Patent is granted, as fully and entirely as the same would have been held by Quantum or Trustee had this assignment and sale not been made.
