I REPRESENT A CONSORTIUM OF INDIVIDUALS, BUSINESSES AND OTHER PARTIES THAT REQUEST A LIEN BE PLACED ON PATENT PENDING No. 09-240,996, PATENT No. 6,409,186 — "A MOBILE CART" — OWNERSHIP UNKNOWN, BUT MAY BE EUGENE KEVIN BENNINGTON AND/OR KATHRYN E. SCHEE DUE TO THE SUBJECT ALL ENCOMPASSING LIEN AS A WHOLE OF MANY PARTS OF LIENS, DEBTS, COLLATERAL(S) AND OTHER ENCUMBERANCES THAT WE ARE PART OF AND ADDITIONALLY HAVE BEEN EMPOWERED TO REPRESENT PER THE ENCLOSED LIEN.

THE NUMEROUS AGREEMENTS BETWEEN E. KEVIN BENNINGTON HIS CORPORATION WITH VARIOUS ENTITIES AND PARTIES AMOUNT TO SIX HUNDRED TEN THOUSAND DOLLARS (\$610,000). THE INTELLECTUAL PROPERTY WHILE PATENT PENDING AS WELL AS WHEN FULLY PATENTED WAS USED AS COLLATERAL FOR THE FOLLOWING LOANS, LABOR, SERVICES AND MATERIALS:

1. LABOR TO BUILD SEVEN (7) PROTOTYPE MOBILE CART UNITS — JANUARY 1993-SEPTEMBER 2002
2. MATERIALS TO BUILD EIGHT (8) PROTOTYPE MOBILE CART UNITS — JANUARY 1993-SEPTEMBER 2002
3. REFRIGERATION UNITS TO BE PLACED ON THREE (3) MOBILE CART UNITS — MARCH 2001
4. ENGINEERING SERVICES TO CREATE FIVE (5) MOBILE CART UNITS — JUNE 1995 — AUGUST 1999
5. \$150,000 LOAN — 1999
6. \$148,222 LOAN — 1996
7. \$14,000 ATTORNEYS SERVICES FOR PATENT APPLICATION

MR. BENNINGTON DID NOT FILE THE NECESSARY DOCUMENTS TO ADVISE OTHER ENTITIES AND PARTIES OF THE ENCUMBERANCES.

MS. SCHEE WAS NOTIFIED ON MANY OCCASIONS BUT FRAUDULENTLY DID ASSIGN THE TOTAL PATENT TO HERSELF AND HAS ATTEMPTED TO COERCE AND EXTORT NOT ONLY MONIES DUE BUT ALSO ADDITIONAL MONIES, SERVICES AND EQUIPMENT FROM ONE PARTICULAR PARTY WITHOUT PROOF, DOCUMENTATION, DUE PROCESS, NOTIFICATION OR REASONABLE ACTION.

MS. SCHEE WAS ASKED TO MAKE A STATEMENT OF FINAL PAYOFF TO MR. BENNINGTON AND TO DIVERSIFIED MOBILITY, INC. BUT REFUSED TO DO SO SO THAT EITHER WILLING PARTY COULD PROVIDE FINAL PAYMENT FOR HER LOAN AGREEMENT. INSTEAD HER ACTION WAS TO ASSIGN THE PATENT TO HERSELF WITH FALSE, FRAUDULENT AND INACCURATE STATEMENTS.

MS. SCHEE HAS DISREGARDED THE ATTEMPTS FOR OVER SEVEN MONTHS TO PAY IN FULL THE REMAINING DEBT OWED HER.

MS. SCHEE ALONG WITH POWER OF ATTORNEY BILL FOWLER OF 3900 58<sup>TH</sup> STREET, SAINT PETERSBURG, FL. 33709 HAVE DONE NOTHING TO RESOLVE THE ISSUES THAT INVOLVE \$612,222 WORTH OF ISSUES AND HAVE DONE NOTHING REASONABLE TO ACT ON ANY ATTEMPTS BY ANY PARTIES INVOLVED TO RESOLVE THEIR COLLECTIVE DEBT. THIS ACTION HAS RESULTED IN LOSS OF BUSINESS, LOSS OF INCOME, LOSS OF TRUST, LOSS OF SYNERGY, LOSS OF CONTROL OF FORWARD MOVEMENT OF THE CORPORATION AS WELL AS LOSS OF REPUTATION.
