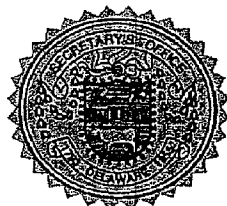


"1. The name of the corporation is Connor Sports Flooring Corporation."
