A S S I G N M E N T

WHEREAS, we, Rolf Farmont residing at Hortensienstrasse 15-17, D-40474, Düsseldorf, Germany, and Johannes Schneider, residing at Am Herrenhaus 5, D-32278 Kirchlingern, Germany, have invented new and useful improvements in **ELECTROMECHANICAL FURNITURE DRIVE MECHANISM** for which we are about to make for Letters Patent of the United States; and
