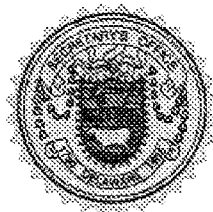

MATSUSHITA AVIONICS SYSTEMS CORPORATION, a corporation duly organized and existing under and by virtue of the General Corporation Law of the State of Delaware (hereinafter referred to as the "Corporation"), DOES HEREBY CERTIFY:

FIRST: That the Board of Directors of the Corporation, by the unanimous written consent of its members filed with the Minutes of the Board of Directors, adopted a Resolution proposing and declaring advisable the following amendment to the Restated Certificate of Incorporation of the Corporation, effective April 1, 2005:

"RESOLVED, that the Board of Directors of the Corporation deems it advisable and declares that, effective April 1, 2005, and subject to the approval of the Stockholder of the Corporation, the Restated Certificate of Incorporation of Matsushita Avionics Systems Corporation shall be amended by changing Paragraph FIRST thereof so that, as amended, the said Paragraph FIRST shall be and

read as follows:

"FIRST: The name of the Corporation is:

PANASONIC AVIONICS CORPORATION".

SECOND: That in lieu of a meeting and vote of the Stockholder of the Corporation, the said Stockholder has given written consent to the aforesaid amendment in accordance with the provisions of Section 228 of the General Corporation Law of the State of Delaware.


THIRD: That the aforesaid amendment was duly adopted in accordance with the applicable provisions of Sections 242 and 228 of the General Corporation Law of the State of Delaware.

FOURTH: That the aforesaid amendment shall be effective April 1, 2005.


