ASSIGNMENT

WHEREAS, I, Carl J. Ruggiero, have invented certain improvements in an IMAGE PROCESSING SYSTEM AND METHOD WITH DYNAMICALLY CONTROLLED PIXEL PROCESSING, for which I filed a U.S. patent application on the date hereinafter set forth; and

I hereby authorize and request the Patent Office officials in the United States and any and all foreign countries to issue any and all of said Letters Patent, when granted, to Enuclia Semiconductor, Inc., as the assignee of my entire right, title, and interest in and to the same, for the sole use of Enuclia Semiconductor, Inc., and its successors and assigns.

Further, I hereby covenant and agree to and with Enuclia Semiconductor, Inc., and its successors and assigns, at the time of execution and delivery of these presents, that I am the sole and lawful owner of the entire right, title, and interest in and to the invention and the above-identified patent application, and that the same are unencumbered, and that I have


good and full right and lawful authority to sell and convey the same in the manner herein set forth.
