**ASSIGNMENT**

- have executed an application for Letters Patent of the United States of even date herewith;

AND We HEREBY covenant that We have full right to convey the entire interest herein assigned, and that We have not executed, and will not execute, any agreement in

conflict herewith.

AND We HEREBY further covenant and agree that We will communicate to said Measurement Systems Inc., its successors, legal representatives and assigns, any facts known to us respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths, and generally do everything possible to aid the said Measurement Systems, Inc. its successors, legal representatives and assigns to obtain and enforce proper patent protection for said improvements in all countries.

AND We HEREBY further assign and transfer to Measurement Systems, Inc. all priority rights derived from such application therefor by virtue of the International Convention for the Protection of Industrial Property for any and all member countries of the aforesaid International convention and We do hereby assign and transfer to Measurement Systems, Inc. the sole right to file further applications for patents under the patent laws of any country of the world based on any improvements disclosed in said application as fully and entirely as the same would have been held by We had this assignment not been made.

AND Measurements Systems, Inc. HEREBY assumes all right, title, and interest in and to this application and the improvements disclosed therein, any Letters Patents or reissues or reexamined patents that may be granted upon said application, to the end of the term or terms for which such Letters Patent are or may be granted or reissued or reexamined.
