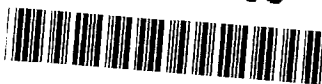

ASSIGNMENT

WHEREAS, I, Bill Kavadeles, residing at 7706 Morada Street, Carlsbad, CA 92009, have invented certain new and useful improvements disclosed in an application for United States Letters Patent titled MODULAR SUPERCHARGER SYSTEM, filed herewith;

AND I HEREBY further covenant and agree that I will communicate to Assignee any facts known to us respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, continuations-in-part, substitute and reissue applications, make all rightful oaths, and generally do everything possible to aid Assignee to obtain and enforce proper patent protection for said improvements in all countries.
