


WHEREAS, I, Gerhard Fuchs, a citizen of Austria, residing at Oberer Lehenweg 106, A-6522 Kauns, Austria, hereinafter called assignor, have invented a certain new ornamental design for a EYEGLASSES, for which I have made application for Design Letters Patent for the United States executed concurrently herewith; and

NOW, THEREFORE, To Whom It May Concern, be it known that for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, I, the said assignor, have sold and by these presents do hereby sell, assign, transfer, and convey unto the said assignee, its successors, legal representatives, and assigns, the entire right, title, and interest in and to the said design and said application, and in and to any and all continuations, continuations-in-part, or divisions thereof, and in and to any and all Letters Patent of the United States and all foreign countries or reissues, reexaminations, or extensions thereof which may be granted therefor or thereon, for the full end of the term for which said Letters Patent may be granted, together with the right to claim the priority of said application in all foreign countries in accordance with the International Convention, the same to be held and enjoyed by said assignee, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by me if this assignment and sale had not been made.

I hereby request that said Letters Patent be issued in accordance with this assignment.

I further covenant and agree that, at the time of the execution and delivery of these presents; I possess full title to the design and application above-mentioned, and that I have the unencumbered right and authority to make this assignment.

I further covenant, and agree to bind my heirs, legal representatives, and assigns, promptly to communicate to said assignee or its representatives any facts known to me relating to said design, to testify in any interference or legal proceedings involving said invention, to execute any additional papers which may be requested to confirm the right of the assignee, its

representatives, successors, or assigns to secure patent or similar protection for the said design in all countries and to vest in the assignee complete title to the said design and Letters Patent, without further compensation, but at the expense of said assignee, its successors, assigns, and other legal representatives.
