ASSIGNMENT

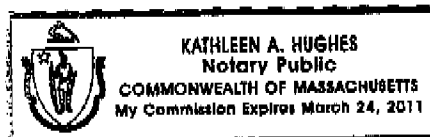


