## ASSIGNMENT OF INVENTION

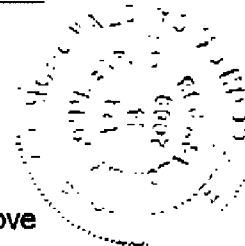
