

ASSIGNMENT AND AGREEMENT

FOR VALUE RECEIVED, we, **Mari KOPONEN and Jukka LAURILA**, citizens of Finland and residing at Lapinniemenranta 12 B 144, FI-33180 Tampere, Finland and Pähkinämäentie 10, FI-37120 Nokia, Finland respectively, hereby sell, assign and transfer to NOKIA CORPORATION, an organization duly organized and existing under the laws of Finland, and having a principal place of business at Keilalahdentie 4, FI-02150 Espoo, Finland, as assignee, and its successors, assigns and legal representatives, the entire right, title and interest, for all countries in and to certain inventions relating to improvements in a **Handling of Acknowledgement Messages in a Terminal**, which is described in an application for Letters Patent of the United States, executed by us on even date herewith, and which claims priority from Finnish Patent Application number **20040112** filed on **January 27, 2004**; and all the rights and privileges under any and all Letters Patent that may be granted therefor.

We request that any and all patents for said inventions in all countries be issued to said assignee, its successors, assigns and legal representatives, or to such nominees as it may designate.

We agree that, when requested, we will, without charge to said assignee but at its expense, sign all papers, take all rightful oaths, and do all acts which may be necessary, desirable or convenient for securing and maintaining patents for said inventions in any and all countries and for vesting title thereto in said assignee, its successors, assigns and legal representatives or nominees.

We authorize and empower the said assignee, its successors, assigns and legal representatives or nominees, to invoke and claim for any application for patent or other form of protection for said inventions filed by it or them, the benefit of the right of priority provided by: (a) the International Convention for the Protection of Industrial Property, as amended, or by any convention which may henceforth be substituted for it; and (b) the Patent Cooperation Treaty, as amended, or by any treaty which may henceforth be substituted for it; and to invoke and claim such right of priority without further written or oral authorization from us.




