ASSIGNMENT AND AGREEMENT



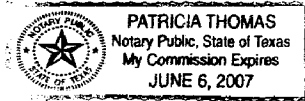
