RELEASE OF SECURITY INTEREST AND RECONVEYANCE OF
INTELLECTUAL PROPERTY

WHEREAS, AAI/ACL Technologies, a Maryland corporation, with offices at 124 Industry Lane, Hunt Valley, MD 21030 (the "Assignee"), on June 28, 2001, in a Grant of Intellectual Property Security Interest (the "Grant"), assigned certain rights, title and interest and granted a security interest in Assignee's patents and copyrights, as set forth in the attached Schedule A (the "Intellectual Property") to Fleet Capital Corporation (the "Assignor");

WHEREAS, the Assignor desires to assign all right, title and interest in the Intellectual Property back to the Assignee, and to release its rights as a mortgagee, pledgee, secured party and conditional assignee under the Agreement as to the Intellectual Property, and Assignee desires to acquire all right, title and interest in and to the Intellectual Property and to accept the release of the security interest in the Intellectual Property.
